

## **OFFUTT AFB Field House Assumption of Risk & (SOU) Statement of Understanding**

I understand and agree that my access to the Offutt Field House during unmanned hours is a special privilege which can be taken away immediately for violation of rules. As an Active Duty, Reservist, DoD Civilian, Family Member or Retiree, I agree to abide by all Field House rules and unmanned rules which will be posted at the Field House. These may be amended from time to time at the discretion of the Director. Violations will result in loss of after-hour access privilege.

- I hereby acknowledge and agree that the Department of Defense, the United States Air Force, Offutt AFB, 55 FSS and the Field House or its staff, are not responsible for member's or their family's safety during unmanned hours and the member assumes all risks associated with using the Field House during those times.
- I will register my Common Access Card (CAC) and sign this SOU and Waiver/Assumption of Risk Form prior to participating in after hour Fitness Access.
- All authorized patrons defined by DAFI 34-114, Air Force Morale, Welfare, and Recreation (MWR) Programs and Use Eligibility, approved by the installation Commander, 18 and older (Active Duty can be age 17) may have access to the FSC during unmanned hours and are responsible to report any misuse, abuse, or violations to Security Forces or the FSC staff.
- Youth under the age of 18 (excluding all Active Duty) are prohibited from using unstaffed facilities. **(T-1)**
- I am not permitted to have guests in the facility during unmanned hours.
- There will be no supervision or assistance during unmanned hours, and I am expected to behave in accordance with military rules and standards. Surveillance cameras will record activities within the FSC during unmanned hours. Violations will not be tolerated. The sponsor will be held responsible for the conduct of family members.
- I will be required to swipe my CAC/Fitness Access card for entry.
- Holding or propping the door open is strictly prohibited and will result in the loss of my privilege.
- Sharing my CAC/Fitness Access card is considered theft of services and will be prosecuted IAW the UCMJ.
- In case of any emergency an emergency phone is in the main entrance.
- The Field House is not responsible for lost or stolen personal property.
- In the event of a power outage, the facility will close immediately.
- Violation of this SOU and Assumption of Risk could result in loss of my privileges and subject to prosecution under the UCMJ and/or any applicable federal and/or state laws.

I certify that I have read and understand this SOU and Assumption of Risk form and fully aware of the published procedures required to utilize the Offutt Field House afterhours access program. I agree to abide by this agreement and will renew my access when required.
